SUBJECT: Enka High School: Turf Replacement Project – Authorization to Award Contract

On February 15 at 2 pm bids were received for synthetic turf replacement at the Enka High School stadium playing field. Four bids were received from approved manufacturers and installers.

The low bidder is Sprinturf at \$430,441. The proposal is in the range expected and within the budget. Sprinturf has offered a credit of \$10,000 per school if awarded both the Enka and North Buncombe projects. Sprinturf recently installed the TC Roberson High School turf project and performed well.

The work will occur over summer 2018 and be complete before the first home football game. Funding for the project will be through School Capital Fund Commission Article 39 Funds. A bid tab and the Board Attorney's opinion letter are included.

RECOMMENDATION: Award installation of the replacement synthetic turf field at Enka High School to Sprinturf in the amount of \$420,441 for the Base Bid. Authorize execution of the contract after receipt of bonds and insurance.
